**Release and Waiver of Liability, Assumption of Risk, and Indemnity Agreement**

In consideration of membership in the All That Cheer and Tumble Training Complex, and being allowed to participate in All That Cheer and Tumble events, practices and/or athletic activities including gymnastics, cheerleading, tumbling, trampoline classes, open gym, open workouts and trial classes the participant named below agree:

Assumption of Risk

1. I, the participant, understand the nature of this gym's activities and sponsored events and certify that I, the participant, is qualified, in good health, and in proper physical condition to participate in such activity.
2. I acknowledge that if I believe event conditions are unsafe, I will immediately discontinue participation in the activity.
3. I fully understand that this activity involves risks of serious bodily injury, including permanent disability, paralysis and death, which may be caused by my own actions, inactions, those actions of others participating in the event, the conditions in which the event takes place, or the negligence of the "releases" named below; and there may be other risks either not known to me or not readily foreseeable at this time.
4. I fully accept and assume all such risks and responsibilities for loses, costs, and damages I may incur as a result of my participating in the activity.

Release and Waiver of Liability

1. I hereby release, discharge, and covenant not to sue All That Cheer and Tumble, its respective administrators, directors, agents, officers, volunteers, employees, any sponsors, advertisers, owners and lessors of the premises on which the activity takes place, (each considered one of the "releases" herein) from liability of claims demands, losses or damages, on my account caused or alleged to be caused in whole or in part by the negligence of the "Releasees" or otherwise, including negligent rescue operation.

Indemnity Agreement

1. I future agree that if, despite this release, waiver of liability and assumption of risk I, or anyone on my behalf, makes a claim against any of the Releasees, I and participant(s) will indemnify, save, and hold harmless each of the Releasees from any loss, liability, damage or cost, which any may incur as the result of such claim.

I have read the RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT, and understand that I and participant(s) have given up substantial rights by signing it and have signed it freely and without any inducement or assurance of any nature and intend it to be a complete and unconditional release of all liability to the greatest extent allowed by law and agree that if any portion of this agreement is held to be invalid, the balance, notwithstanding, shall continue in full force and effect.

And I, as the participant, understand the nature of the above referenced activities and my experience and capabilities and believe I am qualified to participate in such activity.
